

Exhibit Halls A - C - Limitations



Limitations:

- · Linear booths only; Island booths not available in this area
- No water/drain service

Limitations:

Ceiling arches; Rigging points available around arches

Limitations:

- Ceiling height varies; slanted ceiling
- Slopes from the arch face down toward the wall
- Rigging points available, height of sign will vary in this area



Exhibit Halls A - C - Limitations


Height Limits

- The height limit is 24 feet measured from the floor up to the top of the hanging sign; however, there are areas where the height limit is significantly less due to the ceiling arches and lower ceiling areas.
- Ceiling height varies at the ends of Halls A and C. See next page for areas shaded yellow.
- Ceiling arch scale to the right.
- Lighting and truss may be hung above the 24 feet height limit but are not allowed to extend beyond the perimeter of the booth space.
- Rig points:
 - 2,000 lbs max dead hang
 - 500 lbs max bridled between 45° and 90°

Exhibit Hall D - Limitations

Limitations:

- Limited to island booths under 600 sq. ft. unless the booth design can accommodate restrictions below.
- Limited electrical services; booths with minimal electrical needs
- · Hanging Sign must be fabric with no electrical
- No water/drain service
- This area is carpeted but exhibitors may provide their own floor coverings



Limitations:

- Linear booths only; Islands booths not available in this area
- · Limited electrical services
- No hanging signs/No rigging points
- No water/drain service
- This area is carpeted but exhibitors may provide their own floor coverings



Limitations:

- Specialty Area Publishers & Educators
- · Limited electrical services
- Hanging Sign must be fabric with no electrical
- No water/drain service
- This area is carpeted but exhibitors may provide their own floor coverings

Height Limits:

- The height limit is 20 feet measured from the floor up to the top of the hanging sign; however, rigging in this area may be limited due to lack of rigging points.
- All rigging must be straight drops/dead hangs; No bridling is allowed.
- Hanging Sign must be fabric with no electrical

Exhibit Hall E - Limitations

Limitations:

- No water/drain service
- This area is carpeted but exhibitors may provide their own floor coverings

Height Limits:

- The height limit is 20 feet measured from the floor up to the top of the hanging sign; however, rigging in this area may be limited due to varying ceiling heights and or lack of points.
- All rigging must be straight drops; No bridling is allowed.
- Limit of 1,000 lbs per rigging point

Exhibit Hall F - Limitations

Limitations:

- No water/drain service
- Linear booths only; Island booths not available in this area

Height Limits:

- The height limit is 22 feet measured from the floor up to the top of the hanging sign. Lighting and truss may be hung above this height but are not allowed to extend beyond the perimeter of the booth space.
- Rig points:
 - 2,000 lbs max dead hang
 - 500 lbs max bridled between 45° and 90°

Columns:
